The NFU organised an event for county councillors this afternoon on a dairy farm down near Ivybridge which was great and particularly beneficial for those who don't come from a farming background. They spoke about various issues and challenges including the family farm tax and closure of SFI applications. Thank you for your enquiry on behalf of the Parish of Buckland Filleigh.

I have looked into the situation for this parish and can report the following.

Connecting Devon and Somerset (CDS) contracted with broadband supplier Airband in late 2020 to deliver fibre broadband to communities across Devon & Somerset over the course of three years, concluding at the end of 2024. Your area is covered by cluster NF38. Unfortunately, Airband has faced a range of challenges over the intervening years which have delayed delivery of these contracts.

However, following Airband's restructure last year, the company is seeking to maximise take up across its existing network while slowing down on build activity which means it can no longer complete its contracted build for CDS in full. As a result, in April 2024, Airband sought a change to its contract.

Since then, CDS has worked closely with Airband to retain as much coverage across as many communities as possible under the scope of our contracts. This process has had some success in allowing further clusters to be built and I'm pleased to be able to let you know that NF38 is one of them - however, there will be a delay.

This will clearly be extremely disappointing for you, and we share your frustration.

Please keep an eye on the CDS website for a more detailed update on the timeline of build to your premises Connecting Devon and Somerset - rural broadband programme

I am sorry that we cannot bring you more definitive news on the matter, and please do keep Sir Geoffrey updated as to any further news you may receive.

Thank you again for bringing this to Sir Geoffrey's attention.

Councillors discussed this reply. No future action at this time. Clerk informed Councillors that Sir Geofrey will be in Shebbear and Sheepwash on the 29th July 2025 meeting members of the public.
